

## ABBREVIATED OFFICIAL RULES

Must be a legal resident of Japan, 18 years of age or older. Starts **Friday, 20 February 2026** at 12:00 am Japan Standard Time (“JST”), and ends on **Monday, 2 March 2026** at 23:59:59 pm JST. To enter, follow DoubleTree by Hilton Kyoto Station’s official Instagram account, like and leave a comment on the campaign post stating whether you would prefer to enjoy dinner buffet or afternoon tea. ## FULL OFFICIAL RULES

### DoubleTree by Hilton Kyoto Station Spring Instagram Campaign

**ELIGIBILITY:** Only legal residents of Japan, who are 18 years of age or older at time of entry are eligible to enter. **CAMPAIGN PERIOD:** The Campaign begins **Friday, 20 February 2026** at 12:00 am Japan Standard Time (“JST”), and ends on **Monday, 2 March 2026** at 23:59:59 pm JST (the “**Campaign Period**”). The Sponsor’s computer is the official time-keeping device for the Campaign.

**HOW TO ENTER:** Entrants must have access to the internet and must have a valid Instagram account to enter this Campaign. To participate, entrants must do all of the following during the Campaign Period: (a) visit the Sponsor’s official Instagram account (@doubletree.kyotostation) (“**Sponsor’s Page**”) during the Campaign Period and be a follower of the Sponsor’s Page. Following the Sponsor’s Page is free; and (b) entrants must like the Campaign post on the Sponsor’s Page and leave a comment stating whether they would prefer to enjoy dinner buffet, or afternoon tea. Entries need to be submitted via entrant’s own social media account (made public). Entries must be received by the end of the Campaign Period. Proof of submission is not proof of receipt. Entrants may submit only one (1) entry using the same registration information. Each entrant is limited to winning only one (1) prize.

**DRAWING AND WINNER NOTIFICATION:** Subject to verification of eligibility and compliance with these Official Rules, Sponsor will select, on or about Friday, 13 March 2026, four (4) unique winners from all eligible entries. The potential winners will be notified via Sponsor's Page solely at Sponsor's discretion. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within three (3) days after the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner may be disqualified and an alternate winner may be selected. If any potential winner is found to be ineligible, or if they have not complied with these Official Rules or declines a prize for any reason prior to award, such potential winner will be disqualified and an alternate winner may be selected.
